#### Introduction

Lyneal Trust encourages day trips on the Shropshire Lady by groups, including children, where some members have disabilities, illness or injury, or any other vulnerability. The Lady can accommodate up to a maximum of 12 passengers including no more than 2 wheelchairs of a standard size. It is essential that groups include sufficient numbers of responsible, able adults which may be family, friends or carers to ensure safety at all times.

The Trust requires all groups to observe the following responsibilities:

- There must be one person who is in charge of the group (the group Leader).
- The group Leader must be familiar with the appropriate safety rules and ensure that members of the group follow them.
- There must be sufficient people who are not disabled in any way to care for those who are disabled.

It is acknowledged that a high value of benefit and enjoyment can be gained from a day trip on the Lady. However, groups must accept that trips on a canal cannot be completely without risk and the Trust requires that the group Leader takes all reasonable precautions to protect members of the group's health, safety and welfare and to minimise the risk of untoward or dangerous situations. The group Leader must have read the Terms of Conditions of Hire prior to the visit and comply with it.

The Trust is not responsible for assessing the suitability of the location, boats or the type of holiday/day trip for its customers. All visitors, guests, and customers are responsible for their own risk assessments. The Trust, not knowing the individual personal needs of visitors, guests and customers does not and will not undertake personal risk assessments.

The Trust has prepared this Guide to assist group Leaders with planning for the day trip and in assessing the hazards associated with a canal day trip when preparing of their own risk assessment. The Trust is not responsible for checking the adequacy of the group's risk assessment, please see paragraph above.

#### Passenger safety and care

Before the group embarks, the Skipper will ensure that the group Leader and any other nominated group members are briefed on the method of operating the Lady, the equipment that is available for them to use and the role of the Skipper and Crew.

Buoyancy Aids will be offered to all passengers

Before the commencement of every trip the Skipper will ensure all passengers have received a standard safety briefing as prescribed by the Small Passenger Boat Code.

Passengers are forbidden from climbing on the roof or gunwale walkways (the top edge on the side of the boat) at any time.

Where a passenger has been permitted to use the secondary steering system the Skipper or an approved Crew must be in immediate attendance at all times and able to immediately operate the manual override valve which will return control to the primary tiller position and / or to operate the throttle / gear in order to bring the Lady under the Skipper's / Crew's control.



The Skipper and Crew will remain alert to the danger of a person being injured or knocked over board by the hydraulic operation of the primary tiller when the secondary steering joystick is in use. The tiller arc has been marked on the boat's stern deck and no person or item will be permitted to be placed within that arc where they or it may be in danger or cause danger of obstruction.

The prime responsibility of the Skipper and Crew is to operate the boat safely and to ensure the safety of the passengers to the best of their ability and in accordance with their training and the instructions of the Trust. The routine care of passengers, particularly those who are vulnerable either by age, infirmity or disability is a duty for their able-bodied group members or carers.

#### Care of vulnerable people during the trip

Lyneal Trust crew members are not required to undergo criminal records checks or any other form of vetting under local safeguarding provisions *because* they should never become involved in the personal care of vulnerable passengers. This includes the administration of minor first aid which is the responsibility of the vulnerable person's carer. The group Leader must ensure that Crew Members are not put in a situation where they are on their own with vulnerable passengers.

#### What steps will be taken in an emergency or an incident requiring medical attention?

Emergencies requiring immediate assistance should be reported to the Trust's Skipper immediately. Responsibility to call the emergency services by dialing 999/112 will be assigned. The Lady is equipped with a First Aid kit and the Skipper is trained in basic First Aid. The group Leader should decide in advance how to divide responsibilities if a trip is curtailed in the event of an emergency. In this context, it is helpful is a single person is appointed to be in charge of the whole group.

If a member of the group has an accident, please record it the Accident Book and report any First Aid usage to the Skipper.

There are 2 Minor Injury Units in North Shropshire. The Minor Injury Units see all patients with minor injuries. There are no age limits, and you do not have to be a resident in Shropshire to use the facilities.

#### **Arriving at Lyneal Wharf**



When you arrive at the Wharf from Lyneal you will see the car park to the left and the Wharf to the right.

You are asked to park in the car park and cross the lane, be aware of vehicles travelling along the lane, and enter the Wharf where you will be met by your Skipper and Crew.







There may be people holidaying at Wharf Cottage, so we ask you to respect their privacy when making your way up to the canal side. Please use the path next to the lane.







When you arrive at the canal side please be aware of the mooring ropes, bollards and rings.

The Skipper will have installed the ramp to allow easy access onto the Lady.

There is a lift for access into the Lady or there are stairs.
